Listening Attentively, Speaking Clearly

- Positive demeanor
 - Appropriate dress
 - Smile
 - Open body language
 - Good eye contact
- Well organized
- Listen for
 - Facts
 - Understanding
- Speak clearly in even voice
- Ask questions

Writing Well

- Use everyday language
- State your purpose in the first paragraph
- Explain what action you would like to see
- Keep it brief
- Finish the letter politely
- Include contact information

- Gather information

Organizing Medical Records

- Phone log
- Research on your child's condition
- Copies of correspondence with insurance companies
- Important pages from medical and dental records
- Immunization records
- SCOR

Learn about your child's diagnosis

- Ask professionals you are working with
- Education can be empowering or overwhelming
- Check library and Internet



Getting the referral you need

- Your doctor might not know how
- Find out what has worked before
- Work with your healthcare provider



Appealing TRICARE Decisions

- Read denial letter carefully
- Is the decision eligible for appeal?
- Don't be reluctant to question a denial
- Is the reason for the denial accurate?
- What are the time limitations?

- Immunizations and pertinent health records



Evaluation Vocabulary

Do you feel the evaluation is inaccurate?

- Ask informally for more testing to be done
- Ask for an Independent Educational Evaluation
- Arrange a private evaluation

Preparing for the IEP and Eligibility Meetings

- Read results of evaluations before meeting
- Have questions, comments, and suggestions written down
- Speak to parents who have experience with special education
- Bring a photo of your child and family
- Bring your child's education file
- Bring a spouse, friend, or family member

Components of a Good IEP

- Your child's current level of achievement
- Areas where growth is needed
- Activities and services that your child will receive to encourage growth and learning
- How often and where your child will participate in services
- How your child's progress will be measured and at what intervals

Potential Disagreements

- IEP was written before the meeting
- You disagree with the services offered
- IEP is not finished before the end of the meeting


